

2008 GKAI SA OFFICIALS CERTIFICATION CLINICS

We require that all persons who will be serving as **Referee, Starter, or Stroke & Turn Judge** for a GKAI SA team attend one of the GKAI SA Referee or Stroke & Rules Clinics. Additionally, the clinics are an excellent way for parents and other interested persons to learn the technical rules of competitive swimming, the rules and techniques for judging and starting, and other swim meet procedures.

GKAI SA rules require all Referees to attend a Referee Clinic each year and complete a written test. GKAI SA Stroke & Turn Judges must attend a clinic at least once every two years and complete a written test.

Note:

- a. **Persons desiring certification as a Referee must attend one of the Referee Clinics to be held on May 3, May 6, May 10, May 18, May 19, May 20, May 22, May 27, May 31 and June 8.**
- b. **Persons wishing certification as Starter or Stroke & Turn Judge may attend either a Referee clinic or any of the Stroke & Rules clinics to be held at various local pools.**

We have scheduled a number of clinics on various dates, times, and locations for the convenience of team workers and parents, Please feel free to attend any of these sessions.
